BRIAN CAO

Brian Cao has been involved in the spirit industry for over 25 years on the school, all-star, collegiate and professional levels. He has been affiliated with NCA/NDA for the last 27 years and has contributed to both NCA and NDA's summer curriculum as a choreographer and consultant. In 2007 & 2008, Brian served as a Co-Show Director for the Thanksgiving in Paradise Halftime Show in Hawaii, and his choreography & judging opportunities have taken him all around the world, including to the United Kingdom, Canada, Finland and Japan.
